Biographies

Oana Băluță is an Associate Professor for the Faculty of Journalism and Communication Studies at the University of Bucharest, where she teaches Introduction to Political Theory; Contemporary Political Ideologies; Gender and Politics; and Introduction into Mass Media Systems. She also works for the Gender, Minorities and Political Studies department, part of the Faculty of Political Science (National School for Political Studies and Public Administration), where she teaches Gender, Minorities and Political Administration.

Marinko Banjac is a teaching assistant in political theory at the Faculty of Social Sciences, University of Ljubljana, Slovenia, since 2007. He has held the position of a researcher at the same faculty since September 2009. Currently, he is involved in the implementation of the LLP project – Information and Research Activities for "Learning EU at School" entitled "Engaging the Youth – Building the Future".

Petr Čáp works as a community-led local development adviser at the Czech Government's Agency for Social Inclusion. Formerly, he was director of the Civic Education Centre at Masaryk University in Brno (Czech Republic). He is actively engaged in the development of civic education programmes for public libraries in rural areas, postcolonial global citizenship education and popular education programmes with the Homeless Action Group.

Michalina Chrzanowska works as a project manager at the agency labconcepts in Berlin, Germany. She studied German and Romance Studies at the Rheinische Friedrich-Wilhelms University in Bonn and at the Universitat Pompeu Fabra in Barcelona.

Marek Cichocki, PhD is a Polish philosopher, historian of political thought, journalist, conservative columnist and former advisor to Lech Kaczyński, the late President of Poland. Cichocki graduated in German Studies, and in 1998 he received his PhD degree in Philosophy at the Institute of Philosophy and Sociology of the Polish Academy of Sciences. He has published a number of books, essays and articles on philosophy, political science, and international relations.

Nelly Corbel is the executive director of the Lazord Foundation and an independent consultant in citizenship education working with universities and governments around Europe and the Mediterranean. Prior to this, she served as the associate director of the Gerhart Center for Philanthropy and Civic Engagement at the American University in Cairo until March 2015, where she has been providing leadership to a number of programmes.

Antje Drexler is head of the department for international understanding in Europe and the surrounding countries for the Robert-Bosch-foundation in Stuttgart/Germany. She studied slavic studies and economics in Freiburg, St. Petersburg und Göttingen. Her major interests include Science, health and Eastern Europe.

Ingrid Fichter works for the ministry of education as a Franco-German Relationship Officer in Paris. Her expertise includes international relations, especially between France and Germany, administrative law and youth education. She studied at the Pantheon University in Sorbonne (Paris I).

Alban Genty is a Project Manager at the Progressive Zentrum since May 2015. Actively committed to the civic education in France and Europe as co-founder and co-chairman of the French organisation Vote&Vous. Furthermore, Hegedűs lecturer at the Budapest International Managements Semester of the École Supérieure des Sciences Commerciales d'Angers (ESSCA) and member of Team Europe Hungary.

Caroline Hornstein-Tomić, PhD is head of the Operative Division at the German Federal Agency for Civic Education/bpb since April 2016. Previously, she was senior researcher at the Ivo Pilar Institute of Social Sciences in Zagreb and lecturer at the Chair for Anthropology at Zagreb University's Faculty of Humanities and Social Sciences. Her fields of expertise include migration, identity politics, statebuilding and transformation processes in Central and Southeast Europe. From 2001 to 2005 she headed the Konrad Adenauer foundation's country office in Bosnia and Herzegovina.

Martina Horvat graduated social pedagogy at Faculty of Education and Rehabilitation Sciences and is currently attending doctoral studies of social politics at Faculty of Law in Zagreb. Her activities so far include education and training aimed for the improvement of social competence, human rights, civil participation and activities as well as voluntary work.
